The Award aims to recognize chemical transporters with good safety governance and compliance to legislative requirements and it complements the objectives of Responsible Care®. The Award assessment process would also indirectly serve to share good transport practices and transfer of knowledge and learnings to the participating transport companies in general and the industry as a whole. **This year marks the fifth Award organized by CICM and it is sponsored by Lotte Chemical Titan Holding Bhd.**

For the submission of the CICM Safe Road Award 2018 entries, we would like to draw your attention to the following:

- CICM members, Responsible Care signatories and its transporters participating in the Award will be required to download the application form and the relevant Award checklist from the Responsible Care section of the CICM website at <http://www.cicm.org.my>.
- **Submission of the Award Application Form and completed Safe Road Award 2018 Checklist should be made in hard copies and in single-sided paper copy.** Supporting documents are to be submitted in **soft copies** (either CD / DVD form or in a pen drive). *This highly encouraged to reduce paper usage and in line with the objectives of protecting the environment.*
- **Companies are reminded that their declaration in the Safe Road Award 2018 Checklist will need to be supported by relevant documents / implementation evidences of the management practices.** For the Safe Road Award 2018, the period of assessment is from **July 2017 – June 2018.**
- **Prior to submission, companies are advised to check and ensure that the Safe Road Award 2018 Checklist is fully completed.**
- Further information about the Award is explained in the General Information and Terms and Conditions of Participation document.
- The closing date for participation is **not later than July 20, 2018 (Friday).** *Early submission is encouraged.*
